Board Clarifies Rule on Dental Records

The Board has clarified Rule 64B5-17.002, F.A.C. Written Dental Records; Minimum Content Area.

Please review the rule changes and remember the importance of maintaining detailed patient records justifying the course of treatment, including patient history, clinical exam results, results of tests, radiography used for diagnosis and treatment planning and notes concerning treatment rendered to the patient.
